

# PAYRANGE DAILY \$200 VISA GIFT CARD SWEEPSTAKES

## Terms & Conditions:

**Sponsor:** PayRange Inc., a Tennessee corporation; 9600 NE Cascades Parkway, Suite 280, Portland, Oregon 97220 U.S.A.

**Sweepstakes Overview:** The PAYRANGE DAILY \$200 VISA GIFT CARD “Sweepstakes” is open to legal residents of the 50 United States, District of Columbia, and Canada, who are 18 years or older, and who have a valid PayRange App account. The “Sweepstakes” is only open to billiard players who are registered to participate in the American Poolplayers Championship Tournament in Las Vegas, Nevada, April 26<sup>th</sup>, 2023 through April 29<sup>th</sup>, 2023. No purchase necessary. Sponsor "PayRange".

**Sweepstakes Entry Period:** The “Sweepstakes” dates begin on 26 April 2023 and end on 29 April 2023. During the “Sweepstakes” period, the daily “Sweepstakes” period will begin at 12:00AM PT and ends 12:00AM PT each day (the "Daily Entry Period"). A VISA gift card with a retail value of \$200.00, will be given away daily throughout the “Sweepstakes” dates at random to “Sweepstakes” entrants. Entries submitted before or after the Entry Period will not be eligible.

**How to Enter and Eligibility:** The “Sweepstakes” is only open to billiard players registered and participating in the American Poolplayers Championship Tournament in Las Vegas, Nevada, April 26<sup>th</sup>, 2023 through April 29<sup>th</sup>, 2023, who have a PayRange App account, are 18 years or older, and legal residents of the 50 United States, District of Columbia, and Canada.

To enter the “Sweepstakes”, an entrant must have downloaded the PayRange app and registered; and must utilize the PayRange app to send a payment transaction to an APA Poolplayer Championship tournament table that accepts PayRange. Entrants will receive one entry into the daily “Sweepstakes” per every payment transaction to a tournament table. The more times an entrant uses the PayRange app to pay at a PayRange accepted tournament table, the more entries an entrant will receive into the “daily Sweepstakes entry period”. There is no limit to the number of daily entries. The entry must fulfil all requirements of the “Sweepstakes”, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications of the “Sweepstakes” may be disqualified at the sole discretion of the Sponsor. Entrants will receive one entry into the daily “Sweepstakes” per every payment transaction to a tournament table.

**Prizes:** Winners will be selected at random at 10:00am (PT) at the PayRange booth located on the tournament floor. The "Sponsor" and/or Sponsor Representatives will at random draw a prize winner from the “Sweepstakes daily entry period”. The daily “Sweepstakes” winner will receive the following prize:

- The April 29, 2023 daily “Sweepstakes” prize winner will be selected April 30<sup>th</sup>, 2023 at the PayRange booth located on the tournament floor at 10:00a.m.

**Terms and Conditions:** The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes should virus, bug, non-authorized human intervention, fraud, or

other cause beyond the Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes.
